With all due respect to everyone.

My suggestion re the 3 Ratas. May not result in creating 3 separate Ratas. It did not create such a situation for 16 centuries. This does not dilute the strength the strength of the centre in a Unitary state as it did not happen to the ancient capital, Anuradhapura. It will remain the Capital as the central seat of Adminstration. The new amendment could be drafted in such a way.

It is not an emotional concept as somebody observed but a historical fact - time tested.

The merit of my suggestion is that:

- 1. Ensures a balance of ethnic distribution in all 3 Ratas, leaving the Sinhalese in a majority in all 3 Ratas. (This would meet the fears of Susantha too.)
- 2. Eliminates the possible negative outcomes of an attempt to remove the 13th A, by two thirds' majority or by a referendum.
- 3. We could justify it on he ground that we are only going back to a historical division of the country that prevailed in the hay day of the nation which elimeinated all conflicts. May be it could be thus internationally justified.

As pointed out by Mahes, to change the provisions of Article 80(3) the allowed procedure for amending the Constitution will have to be followed such as a 2/3rd majority vote in parliament. The LLRC has suggested that

more time be allowed to the public to have the legality of Bills reviewed by the Supreme Court, as the time available at present to challenge any adverse laws contained in the Bill is One to Three days which is deemed insufficient.

The 13th Amendment has already been submitted to the Supreme Court and ruled as being in order before adoption by the requisite majority in the House. Even if Article 80(3)
